

On October 3, 2022, the US District Court for the Northern District of California preliminarily approved a class action settlement in the case *Rahman, et al. v. Gate Gourmet, Inc., et al.*, Case Number No. 3:20-cv-03047-WHO.

**You could get a payment from a class action settlement if you worked for Gate Gourmet in California as a non-exempt employee at any time from May 4, 2016 through October 3, 2022.**

**What does the settlement provide?** Gate Gourmet will pay \$3,850,000.00 (“Total Settlement Amount”) to end this lawsuit. The proposed deductions from the Total Settlement Amount for payments to the Representative Plaintiffs, Class Counsel, Claims Administrator, and the LWDA are included in the full-length Notice of Class Action Settlement. Class Members will receive a portion of the Net Settlement Amount on a pro rata basis calculated from their non-exempt workweeks worked for Gate Gourmet in California at any time from May 4, 2016 through October 3, 2022.

**How much will my payment be?** Gate Gourmet’s records show you worked <<non-exempt\_workweeks>> non-exempt workweeks during the Class Period. Your total estimated settlement payment will be approximately \$<<estimated\_payment>>. This amount is an estimated amount, and your final settlement payment is expected to differ from this amount (*i.e.*, it could be higher or lower). If you dispute the workweeks shown here, you must follow the dispute procedures set forth in the full-length Notice of Class Action Settlement by January 17, 2023.

**What are my Options?** To receive a digital payment by direct deposit, E-Mastercard, PayPal, or Venmo, go to [www.GateGourmetSettlement.com](http://www.GateGourmetSettlement.com), and select Payment Options by December 16, 2022. If you do not choose a digital payment option, a check will be mailed to your address on file.

To exclude yourself or object to the settlement, you must submit a written exclusion or objection by no later than January 17, 2023. Further details for excluding yourself or objecting to the settlement are set forth in the full-length Notice of Class Action Settlement.
